

ADVANCE BENEFICIARY NOTICE OF NONCOVERAGE (ABN)

NOTE: If Medicare (or other) doesn't pay for <u>service/supply</u> below, you may have to pay. Medicare (or other) <u>MRS</u> does not pay for everything, even some care that you or your healthcare provider have good reason to thing you need. We expect your Medicare (or other) <u>MRS</u> may not pay for the <u>service/supply</u> .

• Choose an option below about whether to receive the <u>service/supply</u> listed above.
Note: If you choose Option 1 or 2 we may help you to use any other insurance that you might have. But Medicare (or others) <u>MRS</u> cannot require us to do this.
OPTIONS: Check only one option. We cannot choose a box for you.
OPTION 1, I want the <u>service/supply</u> listed above. You may ask to be paid now, but I also want Medicare (other) <u>MRS</u> billed for an official decision on payment, which is sent to me on a Medicare Summary Notice (MSN)
I understand that if Medicare (other) <u>MRS</u> doesn't pay, I am responsible for payment, but I can appeal to Medicare (other) <u>MRS</u> by following the direction on the MSN, but if Medicare (other) <u>MRS</u> does pay you will refund any payments I made to you, less co-pays or deductibles/
OPTION 2, I want the <u>service/supply</u> listed above, but do not bill Medicare (other) <u>MRS</u> . You may ask to be paid now as I am responsible for payment. I cannot appeal if Medicare (or other) <u>MRS</u> is not billed.
OPTION 3, I don't want the <u>service/supply</u> listed above. I understand with this choice I am not responsible for payment, and I cannot appeal to see if Medicare (or other) <u>MRS</u> would pay. This notice fives our opinion, not an official Medicare/ <u>MRS</u> decision.
